



## Warranty Veralite® 100 : 5 years

### GENERAL PROPERTIES

Veralite® 100 is a high quality polyester based sheet produced by IPB nv.

Veralite® 100 has the following characteristics :

- high gloss and transparency
- can be cold and hot bent
- high impact resistance
- good chemical resistance

### OPTICAL PROPERTIES

Veralite® 100 retains its clarity and has practically no yellowing during the first 5 years of outdoor exposition.

Veralite® 100 will, after 5 years of outdoor exposure, have a maximum decrease of 10% of light transmission.

Veralite® 100 will have a yellowing index, which will not be higher than 10 points different from what it had at delivery.

The light transmission is tested to DIN 5036 - The yellowing is tested according ASTM D-norm 1925-77.

The samples on which the tests were carried out, were clean and free of any scratches.

### MECHANICAL PROPERTIES

Veralite® 100 has, after 5 years of outdoor exposure, almost no decrease in rigidity and tensile strength.

The flexural modulus will be no less than 95% of its initial modulus at delivery, after 5 years of outdoor exposure.

The flexural modulus is tested to ISO 178.

### WARRANTY CONDITIONS

Conditions for a valid warranty are :

- the material has been invoiced, the customer can demonstrate the following informations : name and adress of sales representative, date of sale and type of material.
- the customer has checked the material at delivery and has registered any abnormality.
- the material is handled, stored, packed and issued according to the manufacturers recommendations.
- the material is not exposed to corrosive chemicals or other products which may attack the material.
- the maximum temperature to which the material is exposed is not higher than 60°C, as advised by the manufacturer.
- the material is not negatively influenced by the way of fastening or sealing.
- the customer has within a week, after seeing the defect, informed the sales representative by letter, in which the type of material is mentioned.
- the customer agrees to a possible visit of the manufacturer, to verify the defect.
- the warranty only applies to clear transparant sheets.
- the warranty only refers to the replacement of free of charge sheets, which would be recognised as being defective and does not take into consideration any other expense or subsequent damage.
